Corporate Snap Shot

Asahi Songwon Colors Limited is a **global market leader** in the manufacture of **phthalocyanine pigments (blue)** and their derivatives.

Phthalocyanine pigments represent one of the largest categories of pigments produced in India. Approximately 40% of these pigments are utilised in the manufacture of printing inks, while the remaining production finds applications in paints and plastics. The Company serves a diverse portfolio of customers, both in India and internationally, with more than 50% of its revenue generated from exports to leading global multinationals.

The Company's state-of-the-art manufacturing facility at **Padra (Vadodara, Gujarat)** produces **CPC Blue Crude, as well as a wide range of Beta Blue and Alpha Blue pigments**. In addition, the Company has strategically diversified into the manufacture of **AZO pigments and Active Pharmaceutical Ingredients (APIs) through its subsidiaries**.

The Company has three subsidiaries, as detailed below:

Asahi Tennants Color Private Limited – Asahi Songwon Colors Limited holds a 51% stake in this joint venture company. The plant is located at Dahej, Bharuch, Gujarat, and is engaged in the manufacture of Yellow and Red AZO pigments.

Atlas Life Sciences Private Limited – A wholly owned subsidiary of Asahi Songwon Colors Limited, with its manufacturing facility situated at Odhav, Ahmedabad, Gujarat. The company produces a range of Active Pharmaceutical Ingredients (APIs) including Pregabalin, R-Compound, Levosulpiride, Amisulpride, Gliclazide, and Phenylephrine, catering primarily to the anti-convulsant, anti-psychotic, and anti-diabetic therapeutic segments.

Atlas Life Sciences (India) Private Limited – Also a wholly owned subsidiary, operating from Chhatral, Gandhinagar, Gujarat, engaged in the manufacture of Active Pharmaceutical Ingredients and bulk drugs for domestic and international markets.
